# 3. Background & Context

Intra-regional trade refers to the exchange of goods and services between countries located in the same geographic region. This can lead to an enlargement in the size of markets thereby creating competition, lower prices and improvement in quality due to competition, increase in entrepreneurship and new business opportunities for firms and enhanced employment opportunities. Regional integration can also reduce countries' dependence on traditional trading partners and raise their resilience against external shocks.

However, trade within African Nations has remained low compared to trade within other regions. Some key constraints to Africa's ability to trade with itself and with the rest of the world include lack of product diversification, high trade costs, poor transport and communications infrastructure, unreliable power, etc.

Also, Intra-African trade remains low because regional trade agreements (RTAs) have not been fully implemented by member-states. Trade tariffs remain high on products, and non-tariff barriers are pervasive across the continent. These impediments affect the ability of African citizens, especially women who are involved in cross border trade as small business entrepreneurs to benefit from the regional integration.
